Are you interested in becoming a member of the Dragons Businessclub? We offer you two kinds of memberships:

Membership 1: Personal Membership from 1 October 2018 till 31 December 2019

A Dragons Businessclub Personal Membership for € 178.00 (€ 215.38 inclusive VAT) per person for a year. The Dragons Businessclub Personal Membership is strictly personal and can only be used by the registered member. Only natural persons who are not acting in the course of his/her professional practice or business can apply for a personal membership.

Your Dragons Businessclub Personal Membership will be automatically renewed after the first period (until the end of the calendar year) for an indefinite period. You can only terminate the membership after the first period taking into account a termination notice of at least 1 (one) month. The membership can be terminated in the same manner that you have applied for the membership, but preferably by e-mail notification to membership@dragonsbusinessclub.nl.

Membership 2: Corporate Membership from 1 October 2018 till 31 December 2019

A Dragons Businessclub Corporate Membership for a year:

- 1 person per organization: € 238.00 (€ 287.98 inclusive VAT)
- 2 persons per organization: € 448.00 (€ 542.08 inclusive VAT)
- 3 persons per organization: € 668.00 (€ 808.28 inclusive VAT)
- 1 **registered** person per organization: € 178.00 (€ 215.38 inclusive VAT)

A Dragons Businessclub Corporate Membership options a.– c. is not restricted to registered persons; different persons of the same organization can attend the events. A Dragons Businessclub Corporate Membership option d. is strictly personal and can only be used by the registered member.

If you wish to register more than 3 persons per organization, please contact us for the fees.

Your Dragons Businessclub Corporate Membership will be automatically renewed annually. The membership can only be terminated by e-mail notification to membership@dragonsbusinessclub.nl. The termination notification has to be received by us before the 1st of December of each year. We will send you a confirmation of the termination.

After your registration you will receive our confirmation with an invoice within 2 weeks.
A one-off registration fee of € 25.00 (€ 30.25 inclusive VAT) is applicable (for Personal and Corporate Memberships).
The fees are based on annual indexation.
